FACTS	<b>WHAT DOES ASCENDANTFX* DO WITH YOUR PERSONAL INFORMATION?</b>	
WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number and employment information</li> <li>▪ Account transactions and transaction history</li> <li>▪ Credit history and wire transfer details</li> </ul>	
HOW?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons AscendantFX chooses to share; and whether you can limit this sharing.

## What we do

<p><b>How does AscendantFX protect my personal information?</b></p>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We further protect your personal information with:</p> <ul style="list-style-type: none"> <li>▪ Employee privacy and security training</li> <li>▪ Strict access controls</li> <li>▪ Confidentiality requirements for employees and service providers</li> </ul>
<p><b>How does AscendantFX collect my personal information?</b></p>	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>▪ Open an account or show us your government issued ID</li> <li>▪ Make a wire transfer or provide account information</li> <li>▪ Tell us where to send the money</li> </ul> <p>We also collect your personal information from others, such as credit bureaus and other companies.</p>
<p><b>Why can't I limit all sharing?</b></p>	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>▪ Sharing for affiliates' everyday business purposes – information about your credit worthiness</li> <li>▪ Affiliates from using your information to market to you</li> <li>▪ Sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for information on State laws.</p>

## Definitions

<p><b>Affiliates</b></p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ AscendantFX is an affiliate of AscendantFX Capital Inc. (Canada).</li> </ul>
<p><b>Nonaffiliates</b></p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ AscendantFX does not share with non-affiliates so they can market to you.</li> </ul>
<p><b>Joint marketing</b></p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ AscendantFX doesn't jointly market.</li> </ul>

## Accuracy

**AscendantFX has procedures in place to respond to requests to correct inaccurate information in a timely manner.**

1. You may verify your personal information on file with AscendantFX by reviewing your account statements from the company(s) that perform clearing services for AscendantFX clients.
2. If you need to inform AscendantFX of a correction you may do so via telephone to +1 (877) 452-7185 or email to [info@ascendant.world](mailto:info@ascendant.world).
3. You should inform AscendantFX immediately if you receive information you believe to be inaccurate.

## Other important information

On request, you shall be informed of the existence, use, and disclosure of your personal information and shall be given access to that information. You shall be able to challenge the accuracy and completeness of the information and have it amended as appropriate.

1. AscendantFX will allow you access to review your nonpublic personal information as retained by AscendantFX.
2. When you successfully demonstrate the inaccuracy or incompleteness of personal information, AscendantFX will amend the information as required. Depending upon the nature of the information challenged, that amendment could involve the correction, deletion, or addition of information. Where appropriate, AscendantFX will transmit the amended information to third parties having access to the information in question.
3. If a challenge to your personal information is not resolved to your satisfaction, the substance of, and reasons for the unresolved challenge shall be recorded and disclosed to you. When appropriate, AscendantFX will transmit the existence of the unresolved challenge to any third parties who have access to the information in question.
4. In certain situations, AscendantFX may not be able to provide access to all your personal information. Exceptions to the access requirement will be limited and specific. The reasons for denying access will be provided to you upon request. Exceptions may include information:
  - a. information that contains references to other individuals;
  - b. information that cannot be disclosed for legal, investigative, security, or commercial proprietary reasons; and,
  - c. information that is subject to attorney-client or litigation privilege.
